

MINI @ Summer Concert Contest ("Contest")

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. ELIGIBILITY

The MINI @ Summer Concert Contest ("Contest") is open only to attendees of the Budweiser Stage concerts on September 2, 2025 and September 4, 2025 in Toronto, Ontario who are legal residents of Canada and are age of majority in the province/territory in which they reside as of the date of entry. The Contest is run by MINI Canada, a division of BMW Canada Inc. ("Sponsor").

You are not eligible if you are: (a) an employee of Sponsor, its divisions, affiliates, subsidiaries, parent or related companies, advertising or promotional agencies, the prize suppliers, or (b) a member of the immediate family (defined as parents, siblings, children and spouse, wherever they reside), or household of any of the above persons.

You may enter the Contest by registering your first name, last name, email address and postal code with a designated MINI representative via an Apple iPad at the MINI display made available for this purpose (the "Official Entry Form") during the Contest Period. Use of any other automated devices is prohibited. You may receive an additional bonus entry (1) if you opt-in to receive communications from the Sponsor at the time of Contest entry.

The clock used by the Sponsor in connection with the receipt of the entries will be the official clock to determine the date and time the entry was received.

Limit of one (1) entry per concert. The odds of winning depend on the total number of eligible entries received. All entries become the property of Sponsor.

Any Entries that are made, or suspected to have been made, through automated means or scripts will be disqualified at Sponsor's sole discretion. The clock used by the Sponsor in connection with the receipt of the Entries will be the official clock to determine the date and time the Entry was received. **Each participant can only use one (1) email account to enter the Contest.**

Selected entrant will be notified by e-mail provided on or about Friday, September 12, 2025. Please check your e-mail and spam filters. To be declared a winner, selected entrant must meet the requirements set out in these Official Contest Rules and correctly answer, without assistance of any kind, whether mechanical or otherwise, a mathematical skill-testing question to be administered at a mutually convenient time by e-mail. Return of any prize or winner notification as undeliverable, inability to reach selected entrant or failure of selected entrant to respond to notification within three (3) business days of first attempt by Sponsor or Sponsor's agent, failure to provide proof of eligibility (if requested), or other required documentation in a timely manner, failure to correctly answer the question, inability to travel on the selected dates or other non-compliance with these Official Contest Rules may result in disqualification, forfeiture of the prize and, at Sponsor's sole discretion, selection of an alternate eligible entrant for the forfeited prize, who will be subject to disqualification in the same manner.

"Authorized account holder" means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. A selected entrant may be required to provide Sponsor with proof that he/she is the authorized account holder of the e-mail address associated with the selected entry.
